### Terms and conditions:

1. Once registered in writing you will receive a written confirmation and the invoice for the course fee. The number of participants is limited. In case the course is fully booked you will be informed accordingly.
2. After having sent the application, the registration is binding upon the applicant, who at the same time agrees to the terms and conditions. The organizers enter liability after having received full payment for the complete course.
3. The course fee is to be paid promptly by bank transfer. The course fee includes all scripts, material and necessary equipment during the course lessons.
4. The course fee does not include any travel and accommodation costs.
5. Deregistration from a course may only be made in writing and leads to cancellation fees:  
Until 4 weeks before the start of a confirmed course: a handling fee of USD \$50,-- + VAT will be charged.  
Cancellation within 4 weeks prior to the start of a confirmed course: a cancellation fee of 25% +VAT will be charged.  
In case of no-show without prior deregistration the cancellation fee is 80%.

7. In case of a short-term cancellation of a lecturer, the participants will be informed promptly. Therefore we kindly ask you for your private/mobile phone number.
